REGISTRATION and REFUND POLICIES

Applicable to All Programs

- **Proof of Age (e.g. birth certificate) must be provided at time of registration.**
- Players are not eligible to participate in any Club programs or activities until the applicable season fees are paid. **All registrations must be completed in full as indicated (e.g. payment received by credit, cash or cheque payable to the Bracebridge Soccer Club) for all applicable program fees.**
- Fees paid at registration sessions in the community may be by cash and/or cheque payable to the Bracebridge Soccer Club as noted at the time of registration. **Please note that the club does not accept post-dated cheques. Credit cards are only accepted through online registration.**
- Registration fees for a program can be transferred to another program in the same season if a change is required. If the change in program requires an additional fee, the registrant must arrange to pay the fee prior to participating in the new program.
- Registration fees for a program will be returned if the Bracebridge Soccer club cancels the program due to insufficient registration.
- Returned cheques due to NSF – a \$40 administrative fee will apply. All fees must be paid within 10 days.
- In the event of circumstances that prevent a registrant from participating in soccer after the season has started, players/parents may apply in writing to the Technical Committee for a full or pro-rated refund of fees paid on compassionate grounds, to be decided on a case-by-case basis.
- Please note that advising a coach / team official or not attending a program does not constitute a notice of withdrawal. Please contact the club if you wish to discuss a refund.
